

OFFICIAL RULES
Ferguson & Bass Pro Shop Big Bass Giveaway 2019

To Enter:

The Ferguson & Bass Pro Shop Big Bass Giveaway 2019 ("Giveaway") begins on May 1, 2019 at 12:00 a.m. ET and ends on July 31, 2019 at 11:59 p.m. ET ("Giveaway Period"). Ferguson's computer will be the official time keeping device of this Giveaway.

No purchase necessary to enter. A purchase will not increase your chances of winning.

Entry method: Go to www.ferguson.com/bigbassgiveaway and complete the brief survey and contact information and submit as directed. Only one entry per person or email address. You must have internet access to enter. You understand that by submitting an entry you are: (1) accepting the terms of these Official Rules and agreeing to be bound by them; and (2) you are opting-in to receive e-mail from Ferguson ("Sponsor"). All e-mail related to the Giveaway will contain opt-out instructions.

Eligibility:

The Giveaway is open only to legal residents of the fifty (50) United States and District of Columbia (U.S.) who are licensed trade professionals in the construction industry and are at least eighteen (18) years of age as of the date of entry ("Entrant"). Proof of trade licensing will be required. If a Federal, state or local government employee wins a prize, they must provide written authorization from their employer confirming they may accept the prize.
